

INTENSIVE ENGLISH PROGRAM (ESL) APPLICATION

STEPS IN COMPLETING THE APPLICATION PROCESS

1. Complete the attached application form. Use the name exactly as it appears in your passport. Sign the application.
2. Provide a photocopy of the information page of your passport.
3. A financial statement is required for students on an F-1 visa. Complete the attached financial statement form. There are two documents you must provide with this financial statement:
 - You will need to provide a statement, signed and dated by the person (sponsor) who will be responsible for paying the student's expenses. The statement declares that the sponsor has sufficient funds in U.S. dollars to pay for this program. An amount must be included. If the sponsor is in the U.S., this document should be signed in the presence of an official or notary public and must have an official seal.
 - You will need a bank statement within the last six months, showing that the sponsor has sufficient funds to meet the required expenses.
4. The application can be sent by one of three methods:

6. We will contact you within four weeks about your admission to the program.
7. Students admitted to the program who have shown proof of finances, will receive an I-20 form from Carroll University, along with instructions for applying for the (F-1) student visa.

Students are encouraged to send in their application materials as soon as possible, to allow time for the visa processing, which can sometimes be delayed.
