TRANSFER OPTIONS

Completed AA or AS degree: Transfer students with an Associate of Arts or an Associate of Arts & Science degree with at least 52 hours of acceptable transfer credit will have the writing seminar waived and will meet all GE 1 distribution components in the general education curriculum. In addition, transfer credit may be received for the CCD, GE2 and CCE requirements. Individual majors may have additional prerequisites and/or requirements.

IAI GECC: Transfer students completing *only* the IAI General Education Core at CLC (no AA/AS) will be evaluated for transfer credit on a course by course basis. General education curriculum requirements must be completed by either transfer or Carroll University credit. Individual majors may have additional prerequisites and/or requirements that are not covered by the IAI.

Completing some courses at CLC: All transfer coursework is evaluated on a course by course basis. General education curriculum requirements must be completed by either transfer or Carroll University credit. There are no minimum requirements for transfer credits completed prior to transfer.

TRANSFER CREDITS

Students from a two-year or four-year accredited post-secondary institution may receive transfer credits provided transfer courses parallel Carroll University courses or are deemed eligible for elective credit. A maximum of 64 credits may transfer from a two-year institution or a combination thereof. A course in which a student received a grade of D may be used to complete general education curriculum and major or minor requirements, but the credit hours will not count as hours toward graduation. All D and F graded courses normally acceptable for transfer credit will be figured into the calculation of the cumulative grade point average. Students must complete their final 32 credits at Carroll, including at least one-fourth of their major credits and at least one-fourth of the minor credits

ADMISSION REQUIREMENTS

Admission to Carroll University is offered to those for whom academic and personal success seems likely. Each candidate is evaluated individually. Evidence of good character and demonstrated ability to do university level work is essential. Students must normally be eligible to return in good standing (be free of academic or disciplinary probation) to all institutions previously attended. A minimum GPA for 2.0 is required for transfer; however, application criteria and academic progression standards for specific academic programs are listed separately in the catalog.

CALCULATION OF ADMISSION GPA

If a student repeated a course in which s/he initially received a grade of C or better and the repeated course had an unsatisfactory grade (D or F), s/he will receive the last grade earned. The final grade will be used in the grade point average calculation.

APPLICATION

Students are encouraged to file an application for admission for the first semester (fall) before March 15. Applications will be considered and qualified candidates will be accepted as long as there are openings in the entering class. Applications and all supporting documents for admission to the second semester should be filed before November 1.

SCHOLARSHIPS

- **EXCEL SCHOLARSHIP** - Renewable scholarship of \$13,000 per year.
Qualifications: Awarded to full-time students transferring into Carroll who have a cumulative GPA between 3.3 and 4.0 for all previous post-secondary work.
- **FOUNDERS SCHOLARSHIP** - Renewable scholarship of \$12,000 per year.
Qualifications: Awarded to full-time students transferring into Carroll who have a cumulative GPA between 2.8 and 3.29 for all previous post-secondary work.
- **HERITAGE SCHOLARSHIP** - Renewable scholarship of \$10,000 per year.
Qualifications: Awarded to full-time students transferring into Carroll who have a cumulative GPA between 2.5 and 2.79 for all previous post-secondary work.
