### Confirmation Deposit

Carroll University requires a \$200 confirmation deposit before students are able to register for classes or housing. The deposit may be paid online at [www.carrollu.edu/emarket](http://www.carrollu.edu/emarket) (click on “International Confirmation Deposits”) or by wire transfer. Students paying the deposit by wire transfer should send a screenshot or verification of the transfer to [international@carrollu.edu](mailto:international@carrollu.edu).

### Insurance Requirements for International Students

Carroll University requires that all students on F-1 visas enroll in the university’s sponsored health insurance. ### Accommodation

All full-time students who enroll at Carroll are required to live on campus. The on campus living requirement can be waived if a student meets one or more of the following qualifications:

- Student has reached senior standing (92 credits or higher) by the beginning of the academic year
- Student is enrolled in a graduate program (Note: On-campus housing is NOT guaranteed for graduate students)
- Student is married or in a partnership legally recognized by a state
- Student is 23 years of age or older
- Student is the primary caregiver of a child
- Student lives within 50 miles of campus with parents or legal guardians

Upon your confirmation to Carroll, you will be required to fill out a housing application.

### New International Student Move-In Day and Airport Pickup

New international student move-in day is the day before International Student Orientation each semester. On-campus housing is not available prior to the new international student move-in date. No exceptions will be made. Complementary airport pickup from Milwaukee’s General Mitchell Airport (MKE) will be provided only on the new international student move-in date and only when requested by the airport pickup request deadline. Students who arrive prior to the new international student move-in date will be fully responsible for arranging their own temporary off-campus accommodations until move-in day.
