<b>Failure to Participate In Mandatory Testing</b>	Student will receive a warning with notice for the student to test within one week of the scheduled mandatory testing	<b>If results not submitted within one week:</b> Mandated meeting with Office of Student Conduct; \$100 fine; removal of access to campus Housing (for residential students) until test results are submitted	<b>If not submitted within two weeks:</b> Mandated meeting with the Office of Student Conduct; Disciplinary Probation 6 months; \$150 fine (in addition to initial \$100 fine)	<b>If not submitted within three weeks from original test date:</b> Required move to virtual learning; Campus Restriction; housing termination without refund (if contracted resident)
<b>Failure to Participate In Contact Tracing</b>	Student will be contacted by contact tracers and are expected to respond. Failure to participate will result in loss of access to campus housing and/or ability to participate in in-person classes			
<b>Hosting a social gathering under recommended limit of 10 (but above housing guest guideline)</b>	Mandated meeting with the Office of Student Conduct; Educational Sanction; Housing Probation	Mandated with the Office of Student Conduct; Housing Termination;		

<b>Participating in a gathering under recommended limit of 10 (but above housing guest guideline)</b>	Mandated meeting with the Office of Student Conduct; Educational Sanction;	Mandated meeting with the Office of Student Conduct; Housing Probation	Mandated meeting with the Office of Student Conduct; Housing Termination	
<b>Participating in social gathering beyond the recommended limit of 10+</b>	Mandated Meeting with the Office of Student Conduct; 14 day quarantine; Housing probation (if incident occurred on campus)	Mandated meeting with college official; Disciplinary Probation; Housing termination (if incidents occurred on campus)	Mandatory move to virtual learning; Campus restriction	
<b>Hosting a social gathering beyond the recommended limit of 10+</b>	Disciplinary probation, Mandatory move to virtual learning, or Suspension; Housing termination if a contracted resident; campus restriction based on severity	Expulsion		
<b>Not adhering to isolation / quarantine</b>	Disciplinary Probation 12 months; Possibility of loss of on-campus housing \$200 Fine; Suspension based on severity	Suspension \$500 fine
